



Resolution Condemning the United States Government's Election Interference against President Donald J. Trump

It has become self-evident that the United States government is interfering with the 2024 election through lawfare aimed at Donald J. Trump. Similarly state prosecutors are also interfering with the 2024 election through lawfare. The incidents of election interference by various government entities, led by the United States' intelligence agencies, are too extensive and pervasive to document, but the low lights include:

- In New York there are 34 felony counts against President Trump, going back to 2006, claiming a payment made to Stormy Daniels was done as hush money to influence the 2016 General Election. However, yet even Stormy Daniels' attorney Keith Davidson took the witness stand and denied the \$130,000 payment from Michael Cohen to his client was a "hush payment".
- In the final weeks of the 2020 presidential campaign, 51 former top intelligence officials falsely signed a letter saying that the alleged contents of Hunter Biden's laptop had "all the classic earmarks of a Russian information operation". This was done as a statement designed to aid Joe Biden's presidential candidacy, and it did. These intelligence officials lied—they all knew it—and the public at large now knows it as well.
- In Florida, Jack Smith, chief prosecutor against President Trump for illegally possessing classified documents, recently admitted to evidence tampering of the documents seized. It was noted that the photo of the documents at Mara Lago were staged with the FBI replacing handwritten sheets with their own "Classified" cover sheets in order to falsely maximize the negative optics towards President Trump.
- All this on top of the recent judgment against President Trump for \$364 million in a fraud trial where there was no fraud, no parties were damaged, and the clients involved testified they sought business with Mr. Trump because he was good business for them.

We the People, see that Stalinist tactics are being employed to deny We the People their right to choose Donald Trump as their President in 2024.

We the People know that these authoritarians will not stop with President Trump, as they have demonstrated by hunting down, demonizing, prosecuting, and jailing countless patriots who protested the 2020 election on January 6, 2021.

We the People know that these authoritarians will expand their targeting to other Americans who do not fall in line with their Marxist movement.

We the People know that these authoritarians employ domestic terrorists such as Antifa, as modern day Brownshirts to intimidate the people with impunity.
